1. GENERAL

- 1.01 This appendix provides supplementary information for crediting charges on test calls.
- 1.02 The appendix provides instructions for crediting customers bills for test and wrong number calls on Switched Services Network Off-Net Access Lines.

1.03 This information was formerly contained in Addendum 010-250-001PN, Issue B which is hereby canceled.

2. SUPPLEMENTARY INFORMATION

2.01 Report verbally to the Administrative Organization Chairman (see Table A) for the particular network involved, all details of test calls made by plant forces on Switched Services Off-Net Access Lines which would cause a charge on the customer's bill. **Keep an information record of these reports locally.** Customers may report wrong numbers in the same manner. The Administrative Organization Chairman will arrange for credit through the proper telephone company business office which handles billing for the off-net access lines that are involved.

CREDITING CHARGES ON TEST CALLS

1. GENERAL

1.01 This addendum provides additional information regarding lists of test numbers. Issue B adds instructions for crediting customers' bills for test and wrong number calls on Switched Services Network Off-Net Access Lines.

1.02 A list of test telephone numbers that will not involve charges may be prepared from information obtained from the Chief Switchman of the serving central office to which the tests are to be made. Such a list should be filed with local copies of this section which are available to craftsmen making test calls.

1.03 Details of Test Calls made by Plant Forces on Switched Services Off-Net Access Lines which would entail a charge on a customer's bill shall be reported verbally by the originator to the Administrative Organization Chairman for the particular Network involved as indicated below. An Info Record of such reports shall be kept locally. Customers may report wrong number calls in the same manner. The Administrative Organization Chairman will arrange for credit through the proper Telco Business Office which handles billing for the Off-Net Access Lines involved.
