

TELEPHONE SET REQUIREMENTS (FORM P-2255)

1. GENERAL

1.01 This practice tells about Form P-2255, Telephone Set Requirements, and how to use it.

1.02 The PSC uses these forms to show the supplyman what equipment the installer needs to complete his work orders for simple service.

2. PREPARING FORM P-2255

2.01 The service order router in the PSC will make up Form P-2255 to show the installer's name, route or stall number and the PSC name. (See Fig. 1)

2.02 Check each service order for the transmission zone code and the type and color of equipment. Make a tally for each item of equipment in the proper space on the form.

2.03 For offices requiring station identification, tally equipment for tip stations, such as 2 party tip, in the "Tip" column. Tally all other equipment in the "Ring" column.

2.04 For offices not requiring station identification, tally all equipment in the "Ring" column.

2.05 List any telephone sets for simple service, not shown on Form P-2255, on a Form P-2170A. Staple it to the back of Form P-2255.

2.06 Where daily delivery of supplies is made from an SDC, send Form P-2255 to arrive at the supply center by 7:00 PM or a time mutually agreed on by the chief line assigner and supply foreman.

2.07 Where delivery of supplies is not made daily from an SDC, prepare Form P-2255 to show "Estimated Telephone Set Requirements" from one scheduled delivery to another, based on the number of sets used since the last delivery. Send this form to the supplies center in time for them to furnish your order on the next delivery date.

2.08 The supplyman will send the Form P-2255 along with the equipment ordered for each route.

3. ORDERING AND RETURNING SETS BY FIELD CRAFTSMEN

3.01 Field craftsmen shall:

(a) Make up Form P-2170A (Order for Material from Supplies Distribution Center) to order sets from the supply storeroom for maintenance replacements or truck stocks when not ordered on Form P-2255.

(b) Return all unused sets to the SDC so they will be available for reissue. Tag them unused.

Note: Leave unused sets in their original containers. Don't put these containers in tote boxes or canvas bags because these are used to send material back to San Leandro.

 (c) Add 634AT sub. set to provide tube ringing.
 (d) Induction coil in set but need bell.
 (e) Requires LBT sub. set.
